



## FORMULA 1®ENGINEERING SCHOLARSHIPS

CALL FOR APPLICATIONS FOR 3 SCHOLARSHIPS, PROVIDED BY FORMULA 1® WORLD CHAMPIONSHIP LIMITED TO ENROLLED STUDENTS AT THE FIRST YEAR OF THE MASTER'S DEGREE PROGRAM IN ADVANCED AUTOMOTIVE ENGINEERING OF UNIMORE FOR THE ACADEMIC YEAR 2023/2024

### ART 1 – PURPOSE

Formula 1® World Championship Limited, for the academic year of 2023/2024, open a competition for 3 scholarships FORMULA 1®ENGINEERING SCHOLARSHIPS to students enrolled in the 1<sup>st</sup> year of the Master's Degree Program in Advanced Automotive Engineering of MUNER- *Motorvehicle University of Emilia Romagna*, established at the University of Modena and Reggio Emilia, and who are in one or more of the following situations:

- physical, social or family disadvantage or in economic difficulty (students who find themselves also in situations such as sudden illness, reduction of family income or unexpected increase in family expenses);
- coming from one of the particularly poor countries or developing countries (identified through a specific annual Ministerial Decree by the MAECI- Ministry of Foreign Affairs and International Cooperation);
- disadvantage related to underrepresented gender in the engineering programs and with particular attention to the opportunities of professional and career inclusion in the sector of Formula 1®;
- status of students recognized as stateless or holders of international protection (with a residence permit for political asylum or subsidiary protection), or holders of a residence permit for humanitarian reasons, or special protection and special cases;

The maximum fund of each scholarship is around 12,000.00 euro (exchanged of 10,300.00 Pound) per year. The contributions will be paid within the set limits and until the available budget is completely allocated.

### ART 2 – ELIGIBILITY REQUIREMENTS

Scholarships will be granted to students who, in the academic year 2023/2024, are enrolled in 1<sup>st</sup> year of the Master's Degree Program in Advanced Automotive Engineering of at MUNER - *Motorvehicle University of Emilia Romagna* established at UNIMORE, and find themselves in one or more of the following situations:

- a) Students with low income or who find themselves in serious economic situations due to a significant increase in expenses or a significant decrease in available income;
- b) Serious illnesses and disabilities that affected the student or one or more of their family members;
- c) International students with refugee status;
- d) International students from countries not belonging to the European Union and who are "particularly poor or developing countries" according to the D.M. 28-2-2023, No. 115 of MAECI;

- e) Students in disadvantage related to underrepresented gender in the engineering industry and with particular attention to the possibility of professional and career inclusion in the sector of Formula 1®.

The situations referred to in the above paragraph must not have occurred any earlier than 18 months before the opening date of this call. The selection committee has the possibility to evaluate particular situations of disadvantage that occurred earlier than 18 months and still have unsolved consequences.

### **ART. 3 – TARGET**

All students regularly enrolled in the academic year 2023/2024 in the first year of the Master's Degree Program in Advanced Automotive Engineering and not older than 35 years.

### **ART. 4 – TERMS AND APPLICATION**

- Those who applied online ERGO a.y. 2023/2024 and are eligible to one or more of the following benefits, study scholarship, place in accommodation, notax area, reduction of university fees, are not required to fulfill any obligation, except as indicated in point c) below.
- Those who have not applied online ERGO for scholarship a.y. 2023/2024 or those whose foreign income and assets documentation is not complete, must complete the no tax area application section <http://www.er-go.it/index.php?id=3600> and submit, for international students with income and assets abroad, the documentation according to the procedures required by the call for benefits, except as indicated in point c) below.
- In all cases, further and specific conditions or any other situations of difficulty (referred to in Article 2 ELIGIBILITY REQUIREMENTS) can be declared using the form attached to the Call "Application form" to be sent by email to [servizi.studenti@unimore.it](mailto:servizi.studenti@unimore.it).

All of the above must be completed on the website [www.er-go.it](http://www.er-go.it) and/or submitted to [servizi.studenti@unimore.it](mailto:servizi.studenti@unimore.it) no later than **December 20th 2023 h.3 pm**

### **ART 5 – SELECTION COMMITTEE**

- The selection committee will be composed of at least 3 members of the study council of the program in Advanced Automotive Engineering, chosen the program's director.
- The selection committee will be supported by administrative staff of UNIMORE. This latter will verify that the requirements in the call for application are met.
- The selection committee will proceed at its sole discretion to formulate a ranking of merit for the assignment of the scholarships based on the selection criteria specifically established by the committee.
- The commission is also competent to decide for situations not defined in the call for application.

In case any dispute arises from this call for application, the selection committee will have to decide what the correct interpretation will be. Its decision will have to be formalized through Rector official act.



#### **ART 6 – FORMULATION OF RANKING**

The rankings of merit for the assignment of the scholarships will be formulated according to the criteria and the scores defined by the selection committee. The score defined by the scientific committee and will be published in the [Albo On Line](#) – Official University Register. In case of a tie scoring, academic career will be assessed.

#### **ART 7 – PROVISION OF SCHOLARSHIP TO THE WINNERS**

Successful students will be informed through the online publication of the ranking in the [Albo On Line](#) – Official University Register.

For the provision of the scholarships, the student is required to formally accept to enter their Italian bank details, IBAN, on the personal page of Esse3. The payment of the scholarship might be made through the Regional Agency for the Right to Higher Education ERGO.

#### **FIRST YEAR**

*The first installment of the scholarship- equal to 50% of the total amount of the first year – will be paid after the publication of the eligibility ranking.*

*The second installment of the scholarship- equal to 50% of the total amount of the first year – will be paid upon reaching at least 30 credits no later than 10/08/2024.*

*The requirements for the following years are as follows:*

**SECOND YEAR:** achievement of 80 credits on 10/08/2025

**LAST SEMESTER:** achievement of the master's degree by 10/08/2026

In the case of failure to achieve the academic objectives specified above for the renewal of the scholarship in the years following the first, or of transfer or withdrawal of the university career, the student will keep the sum(s) of the money received but will lose the right to receive the remaining sums. In this case, the ranking will be scrolled and the remaining amount will be assigned, net of the sums already paid to the previous student, to the candidate high in the ranking with the forementioned requirements.

#### **ART 8 – REVOCATION OF SCHOLARSHIP**

The contribution will be revoked in case substantial discrepancies are found between what is declared by the student and their actual economic, financial or family situation, along with the immediate request for the refund of what was unduly received.

#### **ART 9 – ADVERTISEMENT AND PROMOTION OF THE SCHOLARSHIP**

This call is published on the [Albo On Line](#) – Official University Register. The Department and Study Program involved promote adequate communication, guidance and orientation initiatives aimed at the widest dissemination of this notice and the subsequent dissemination of the results and related promotional actions.

#### **ART 10 – PROCESSING OF PERSONAL DATA AND ACCESS TO PROCEDURE DOCUMENTS**
